Before You Go Home:

- Complete driver improvement clinic (if required)
- Research your court fines and costs

After You Are Released: Ask Drive-to-Work to Assist

- Application and current DMV record
- Gross income less than twice the federal poverty level
- A job or other source of funds to pay costs
- \$250 administrative fee (higher for complex cases)

HOW TO REMOVE SUSPENSIONS FOR UNPAID FINES

- Fines listed by court on DMV Compliance Summary
- All fines must be removed before applying for license
- Obtain the case number and amount of each fine
- Strategy
 - Pay off any court in full if you can Pay the clerk or collection agency Take receipt (Form DC-30) to DMV
 - Request pay plans for other courts
 Pay down payment monthly payment until paid in full
 Take receipt (Form DC-30) to DMV
 Courts must offer a pay plan with a reasonable down payment (such as 10%)

HOW TO REDUCE THE INTEREST YOU OWE

- Courts will waive interest on all fines for periods while you were incarcerated
 - A person incarcerated nine years saved over \$2,000 (28% of his fines)
- Get a certificate of incarceration period (Form DC-366) from DOC or jail
- Present this certificate to clerks of courts where you owe fines and costs

HOW TO GET A RESTRICTED LICENSE

Are you eligible?

- Does the law allow it?
- Are all fines removed?
- Do you have a reason to drive?
- Do you need to enroll in VASAP?

Apply to court that convicted you

- List the specific details of where and when you need to drive
- Stay within the approved terms of the restricted license

Restricted Licenses

- Purposes
 - To and from work
 - At work, with employer's OK
 - Medical appointments
 - Children to school/medical
 - Meetings with your probation officer
 - Church



- Authorized for Specific Suspensions
 - Driving on suspended license
 - DUI
 - Drugs
 - Habitual offender
 - Fines
 - Child Support
- Not allowed for commercial license

THERE ARE SERIOUS CONSEQUENCES FOR DRIVING OUTSIDE TERMS OF RESTRICTED LICENSE!
